**PARENT/GUARDIAN AGREEMENT**

I, the parent/guardian of the registrant, a minor, agree that the registrant and I will abide by the rules of the USYSA and MYSA, it's affiliated organizations and sponsors. Recognizing the possibility of physical injury associated with soccer and in consideration for the USYSA and MYSA accepting the registrant for its soccer programs and activities (the "Programs"). I hereby release, discharge and/or otherwise indemnify the USYSA and MYSA, its affiliated organizations and sponsors, their employees, and associated personnel, including the owners of fields and facilities utilized for the Programs, against any claim by or on behalf of the registrant as a result of the registrant's participation in the Programs and/or being transported to or from the same, which transportation I hereby authorize.

**VOLUNTEERING & FUNDRAISING - WAIVED FOR FALL TRAVELING SEASON**

There is a requirement that all families participate in volunteer activities or a fundraising activity for the club. This is equivalent to 4 hours volunteering or \$50 profit per player for first 2 players per family, for maximum of 8 hours or \$100. This helps to defer some of the cost for Forest Lake soccer and provides much needed manpower that ensures our club's success. In addition, scholarship recipients will also be asked to volunteer an additional amount.

**PLAYER TRANSFER RELEASE**

Any player signing a player registration form to play for FLSA is bound to the assigned team for that soccer season unless the player requests a transfer and the transfer is approved. A request for transfer must be made in writing specifying the reasons and with copies being sent to the coach and FLSA president who will make a determination. This decision can be appealed following the appeal process of MYSA. Player transfers may only be approved for the following reasons:

- 1. Player relocates to a different community.
- 2. Voluntary release by club.
- 3. Player's desire to play at a higher level which is not available at FLSA.

**REFUND POLICY**

**No refund will be given without a written request from the parents.** Refunds: \$25 is considered non-refundable to cover administrative costs and expenses. Any player signing up but withdrawing will be assessed this charge. If a player drops after registration close date, September 1, 2010, and after submittal to MYSA, no part of the fee is refunded.
